## NY-GEO TOP JOB COMPETITION ("Top Job") OFFICIAL RULES

TOP JOB OVERVIEW: NY-GEO invites the entrants to share the details regarding a geothermal design/installation to inspire an audience of stakeholders to the breadth, depth, and how-to's to successfully sell, design, install, finance, and/or service a geothermal heat pump application. Entries will be judged to determine three (3) awardees. Each awardee (defined below), will automatically receive one (1) entry into the NY-GEO Annual Conference (NY-GEO-2024). Judging will be done in advance, each awardee will have 8-10 minutes to make a virtual presentation at NY-GEO 2024 (defined below). Judges will collaborate and determine a winner.
- 2. ELIGIBILITY: The Top Job is open only to legal residents of any of the 50 United States, D.C., Puerto Rico, or Canada, who are engaged in the business of selling, designing, installing, financing, and/or servicing geothermal heat pump projects and who are 18 years of age or older at the time of entry.

- 4. TO ENTER: During the Entry Period, NY-GEO invites participants to submit their project details and narrative, participants will be required to submit the following:
- (i) Full name of presenter
- (ii) Company position/affiliation
- (iii) Presenter phone #
- (iv) Presenter email address
- (v) Project name
- (vi) Identify what categories best characterize the project's unique features
- (vii) Project address
- (viii) Project description
- (ix) Acknowledge and submit written authorization by the project owner approving the submission of this project for Top Job consideration
- (x) Additional project documentation as deemed relevant by the presenter (high-resolution pictures/images are encouraged).

Participants should review the NY-GEO website for details and submit their Entry on-line: https://www.ny-geo.org/2024-top-jobs-application/ and follow the on-line instructions to complete and submit your entry.

## 5. ENTRY GUIDELINES:

- All Entries must be received and recorded within the Entry Period.
  The NYGEO's computer is the official timekeeping device for entry submission.
- You may enter as many different Entries into Top Job as you like, as long as the same project is not submitted more than once.
- Entries must be in English.

NY-GEO reserves the right to monitor or screen Entries before posting them to the Web site, in its sole discretion. By entering, you acknowledge that your Entry may be posted on the website at NY-GEO's sole discretion. NY-GEO has no obligation to use or post any Entry you submit.
